Release of Liability and Policy and Procedures/Code of Conduct

The following policies and procedures govern the Las Lomas All Knighter and must be acknowledged by all students and their parents in order for the senior to attend the All Knighter.

Objective: Provide a safe, enjoyable celebration to culminate graduation for the Class of 2019

- Admission will be granted to paid Las Lomas graduating seniors beginning at 9:00 pm
- No graduate will be admitted after 10:30 pm
- Parent(s) named below will be notified by phone of any paid graduate not checking in within the prescribed time period
- Graduates under the influence of alcohol or drugs will not be admitted and their parent/guardian will be notified to pick them up at Security. We WILL breathalyze and check for hidden belongings upon check-in.
- Graduates will not be allowed to depart and return (no in and out privileges)
- *To ensure your graduates safety, he/she will be permitted to leave before 4:30 a.m. only AFTER an All Knighter volunteer has spoken with the parent/guardian named below to obtain verbal consent.*
- All valuables will be held at bag check. NO BACKPACKS OR LARGE BAGS ARE ALLOWED.

Note: Anything taken into the All Knighter (cell phones, cameras, etc.) are taken in at own risk. We are not responsible for lost or stolen items.

Behavior: Everyone will be expected to conduct themselves appropriately: Graduates are not permitted to bring in any alcohol, tobacco, drugs, food or drinks of any kind. Inappropriate behavior such as fighting, rough-housing, destruction or defacing of property, drinking alcohol, smoking, vaping or the use of drugs will not be tolerated. Inappropriate or negative social media posting on any site/app will be cause for dismissal. The parent/guardian of any graduate engaging in such behavior will be required to pick them up at Security within 30 minutes or they will be released to Concord Police.

Acknowledgement and Acceptance of Risk: I/We understand and acknowledge that this event (Las Lomas All Knighter, June 7-8, 2019) involves interactive games, activities and amusements including climbing, sliding, jumping, bowling and interacting with other participants and that it brings with it both known and unanticipated risks which could result in injury, death, illness, disease or damage to participant or participant's property.
